Congratulations! You have finished the 2019 PCA rodeo season among the top 15 contestants in your event. In order to qualify for the 2019 Professional Cowboy Finals Rodeo you must be among the top 15 in the points, you must have competed in at least 12 PCA sanctioned rodeos as a PCA member and you must meet all eligibility requirements. The 2019 PCFR will be held in Biloxi, Ms @ the Mississippi Gulf Coast Coliseum on January 10th through the 12th, 2020

Enclosed you will find a contestant application and a stall request form. All information must be completed and received by the PCA office no later than December 13, 2019. **All Entry Fees & fines and/or turnouts must be paid by December 16, 2019 (no personal checks – we take Money Orders – Cashier Checks or AMEX-VS-MC-Disc with a \$10.00 charge).** The call in to enter the PCFR will be **Monday December 16th, 2019** from 9:00 am to 3:00 pm (CST) at (251) 947-4650 **MUST BE PERSONALLY CALLED IN TO ENTER.** Everyone must call to enter; failure to do so will result in disqualification.

There will be a **mandatory meeting** for all contestants on Thursday, January 09, 2020 at 6:00 PM at the Mississippi Coast Coliseum Convention Center and a Calcutta will follow. The rodeo will start with the first go around Friday morning, Friday night, Saturday night and Sunday afternoon. Anyone who is not present for roll call will be assessed a \$300 fine that must be paid before competing. **No exceptions!** Everyone must be in full western attire for the meeting and must participate in the group pictures following the meeting.

Stalls will be available for the duration of the finals. All horses must be stalled or removed from the grounds following each performance; no horses may be left tied to trailers. **No hookups available. There will be a designated area for horse trailers.**

Professional Cowboy Finals Rodeo Ground Rules

1. All contestants will be required to be in full western attire, including back numbers, at all PCFR functions.
2. Back numbers must be worn at all times
One back number will be provided to be worn at all 4 performances.
There will be a \$500 fine for any misconduct anytime or anywhere for the duration of the finals. You will be responsible for any misconduct of your guests at any PCFR functions. If you are fined for misconduct, full amount must be paid before you will be allowed to compete.
3. PCFR Jackets must be worn during the Grand Entry. NO EXCEPTIONS!
4. Back gate will be open for the Breakaway Roping event.
5. Only the breakaway string provided may be used.
6. No unauthorized personnel will be allowed in or behind the arena and chutes.
Only back numbers and staff badges only. NO EXCEPTIONS! In the steer wrestling, hazers that are not competing in the PCFR will need to see the secretary for a back numbers prior to the first performance.
- 7. Only the Office Secretaries and Rodeo Secretaries are allowed in the office.**
8. During events, only contestants entered in that event will be allowed in the arena.
9. Contestants will not be permitted to walk down the arena. You must either ride a horse or go around.
10. Any contestant that parks their vehicle in the alleyway coming into the coliseum will be fined \$100. This area must stay clear in order for the stock to be transported back and forth to the arena.
